As part of **Law Week 2019** the **Cairns Magistrate Court**, in conjunction with the **Legal Faculty JCU** and the **Business Liaison Association & special sponsors, Brien Leibinger Law**, are running a **Year 11 & 12 Mock Court Competition** evening on **WEDNESDAY 15<sup>th</sup> May 2019**.

- This competition will have **Local legal practitioners & JCU students** as the judges.
- As well, there may be an **evening seminar on court procedures** and protocols run by the Magistrates & JCU in the week prior the competition, possibly Wednesday 8<sup>th</sup> 4:30-5:30pm.
- The court case will be a **criminal** hearing so it should suit all Legal Studies students.
- Each participating school can enter more than one team as long as there are sufficient places in the competition. **Each team consists of 6 players: 2 counsel, 2 witnesses, 1 solicitor & 1 court officer.**
- A Registration Fee of \$88 (GST incl) will be charged per school not per team. The Business Liaison Association will invoice each school.
- There will be the prizes awarded for both the winning and runner up teams. These prizes will be sponsored by Brien Leibinger Law. **All teams will receive Certificates of Participation from the BLA.**
